Basic instructions:

1. All described actions are taken as soon as the competent authority (Police - Fire Department) announces to the coordinator of the Crisis Management Team AMEX, the command to evacuate the premises.

2. All employees try to remain calm and cope to any visitor's reaction with courtesy and reassuring manner so to avoid any tension. Also make sure that during the interruption of your work, a risk does not pose to your premises (eg. kitchen equipment shutdown, parking forklifts and other vehicles off escape routes, close radiators). 3. Focus on the actions of your absolute power and do not engage in arbitrary or other actions to ensure the immediacy and tranquility to your actions.

4. Follow the instructions of those responsible for the respective areas.

5. When the discharge cause is under full control and that there is a confirmation of the relevant departments there is no risk to recover all the facilities, only the head of the Greek Police, in consultation with the Chief Fire and General Manager, decide to return and reopen the facilities.
